The other guy, uh, suspect, I saw with a gunshot wound to the chest, um, and also to his leg. Those are the only injuries I

could see at the time.

Okay, and uh, did you notice anything laying around on the floor?

Yes I did see, uh, two bullet cases on the floor.

Okay, just casings?

DeLancy:

Yes.

Okay. Um, what about the off duty's weapon?

So I stayed there with the one that, right in between both of them keeping my eye on both of 'em, since one of them was not handcuffed. Um, asked fireboard did they want handcuffs off the other one. And she asked me would I stay there. I said, yes, I'm here to, um, keep an eye on them. And then she said, yes, okay, we can take off the handcuffs. At that time, um, Cpl. Jones came upstairs with a handcuff key and removed the handcuffs off the first suspect.

Okay and then what did you do?

DeLancy:

I continued to stand there until fireboard, other fireboard members came and, um, and when they were taking him out. I stay with the second suspect. The one that was shot in the chest. Um, I came outside with him. I got in back of the

ambulance with them and we, uh, proceeded to, uh, Pine and 210, which is where the helicopter landed for them.

Walls:

Okay, and so you stood by, um, they were loaded on the helicopter?

DeLancy:

Right. I didn't go to the helicopter. I stayed with the ambulance.

Walls:

Okay, and what did you do after that?

DeLancy:

Then I got into the car with my sergeant and came back to the scene.

Walls:

Okay, and did you have any duties and responsibilities once you arrived back on

the scene?

DeLancy:

No I did not.

Uh, I went in the house and, uh, I walked up the stairs and I saw one marked officer at the top of the stairs, uh, and the one unmarked officer also at the top of the stairs, both, uh, uh, both patients that were shot were both handcuffed, um, I went to the first patient that was to the left of the stairs, almost immediately at the top of the stairs. Um, and my partner Josh Carlson, he went to the right and took the other patient. Uh, started cutting the clothes off of my patient, Brandon, and uh, noticed that he was shot twice. Um, I looked up and saw the unmarked uniform officer, uh, saw that he had a couple hits to the face. I asked if he was okay. He said, he was. I continued doing my patient care. Um, with Brandon. And I asked the marked officer to remove the handcuffs so I could, uh, continue patient care. The patient was in a lot of pain. And so I cut his clothes off. I found two shots, uh, one to the upper abdomen and one to the right knee.
